# 1. はじめに

本書では、弊社 PC サーバ PRIMERGY にて VMware Infrastructure 3 を使用する場合の、RAS支援サービスのインストール・設定について説明しています。

## 2. RAS支援サービスのインストール

#### 2.1 RAS支援サービスのインストール・設定

PRIMERGY の寿命部品を監視できるようにするため、Service Console 上から RAS 支援サービスをインストールします。 RAS 支援サービスを使用するためには Service Console に RAS 支援サービスの拡張パッケージ (Web サーバ: httpd(Apache)) を導入する必要があります。

- 注)「PRIMERGY スタートアップディスク」は使用できません。
- 1. VMware Infrastructure 3 のService Consoleにrootユーザでログインします。
- 2. RAS 支援サービス 拡張パッケージ (Web サーバ) のインストールを実施します。

「PRIMERGY ドキュメント&ツール CD for VMware バンドルタイプ用」をセットし、以下のコマンドを実行します。

- # mount /mnt/cdrom
- # cd /mnt/cdrom/RAS\_VMI3/MTEP
- # ./install.sh
- 3. 以下のコマンドを実行して、Web サーバに割り当てるポート番号で通信できるように、ファイアーウォールの操作を 実施します。
  - # esxcfg-firewall --openPort <port-number>,tcp,in,"httpd"
  - # esxcfg-firewall --openPort <port-number>,tcp,out,"httpd"

<port-number>には、Web サーバ用に割り当てるポート番号を指定します。

以下に"9642"を割り当てる場合の実行例を示します。

実行例:

- # esxcfg-firewall --openPort 9642,tcp,in,"httpd"
- # esxcfg-firewall --openPort 9642,tcp,out,"httpd"
- 4. 以下のコマンドを実行して、VMware のサービスを再起動します。
  - # service mgmt-vmware restart
- 5. /etc/httpd/conf/httpd.conf を編集ツール (vi 等) で修正し、Web サーバのポート番号を設定します。
  - ※ Web サーバのポート番号に"9642"を割り当てる場合、以下の設定変更は必要ありません。

[変更前]: Listen 9642

[変更後]: Listen <port-number>

<port-number> には、Web サーバ用に割り当てるポート番号を指定します。

- 6. 以下のコマンドを実行して、Web サーバを起動し、システム起動時に自動起動するように設定します。
  - # /etc/init.d/httpd start
  - # chkconfig --level 3 httpd on

- 7. 以下のコマンドを実行して、RAS 支援サービスのインストールを実施します。
  - # cd /mnt/cdrom/RAS\_VMI3/RASv311
  - # rpm -ivh RASAssist-3.1.1-01.i386.rpm
- 8. 以下のコマンドを実行して、Web サーバを再起動します。
  - # /etc/init.d/httpd restart

以上でRAS支援サービスのインストールは完了です。

## 3. 留意事項

## 3.1 RAS支援サービス最新ソフトウェアの入手

PC サーバ PRIMERGY (プライマジー) のサイトのダウンロードページ (http://primeserver.fujitsu.com/primergy/downloads/) から最新版ソフトウェアが入手できます。

#### 3.2 RAS支援サービスのアップグレード

RAS 支援サービスをアップグレードする場合は、事前にRAS 支援サービスをアンインストールしておく必要があります。 アンインストール前に、予めRAS 支援サービスのWeb-UI を開いて、UPS/RAID バッテリの搭載日や稼働時間をメモしておいてください。アップグレード完了後、メモしておいた搭載日や稼働時間をWeb-UI から再設定してください。

### 3.3 RAS支援サービスのアンインストール

RAS 支援サービスをアンインストールする場合は、以下の操作を実施してください。 注)RAS 支援サービスの Web-UI を開いている場合は、全て終了してください。

- 1. VMware Infrastructure 3 のService Consoleにrootユーザでログインします。
- 2. 以下の操作でRAS 支援サービス パッケージをアンインストールします。 # rpm -e RASAssist

#### 3.4 RAS支援サービス 拡張パッケージのアンインストール

RAS 支援サービス 拡張パッケージ (Web サーバ) のアンインストールは以下の手順で行います。 ただし、拡張パッケージをアンインストールすると RAS 支援サービスは使用できなくなります。

- 1. VMware Infrastructure 3 のService Consoleにrootユーザでログインします。
- Web サーバを停止します。以下のコマンドを実行してください。
   # /etc/init.d/httpd stop
- 3. 割り当てたポート番号で通信できないようにファイアーウォールの操作を実施します。
  - # esxcfg-firewall --closePort <port\_number>,tcp,in
  - # esxcfg-firewall --closePort <port\_number>,tcp,out

<port-number>には、Web サーバ用に割り当てたポート番号を指定します。

以下に"9642"を割り当てていた場合の実行例を示します。

実行例:

- # esxcfg-firewall --closePort 9642,tcp,in
- # esxcfq-firewall --closePort 9642,tcp,out
- 4. 以下のコマンドを実行し、VMware のサービスを再起動します。
  - # service mgmt-vmware restart
- 以下の操作でパッケージをアンインストールします。
  - # rpm -e httpd-1.0-1.FJ
